AN ORDINANCE REVERTING THE AMOUNT OF TWO HUNDRED SIXTY THREE THOUSAND SEVEN HUNDRED NINETY SEVEN PESOS (P263,797.00) FROM SALARY LAPSES OF VACANT PLANTILLA POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO), AND APPROPRIATING THE SAID AMOUNT AS WELL AS THE AMOUNT OF ONE MILLION FIVE HUNDRED TEN THOUSAND ONE HUNDRED FIFTY THREE PESOS (P1,510,153.00) FROM THE 2016 SURPLUS, TO OTHER GENERAL SERVICES OF VARIOUS OFFICES:-


