AN ORDINANCE REVERTING TO UNAPPRPRIATED BALANCE THE AMOUNT OF ONE MILLION TWELVE THOUSAND FIVE HUNDRED PESOS (P1,012,500.00) FROM UNUTILIZED TRAINING EXPENSES OF VARIOUS OFFICES, AND APPROPRIATING THE SAME TO BARANGAY SUPPORT FUND UNDER SPECIAL PURPOSE APPROPRIATIONS (SPA) TO FUND THE BARANGAY PERFORMANCE INCENTIVE (BPI) OF BARANGAY OFFICIALS:-

Be it ordained by the Sangguniang Panlungsod of the Naga, that:

SECTION 1. - The amount of One Million Twelve Thousand Five Hundred Pesos (P1,012,500.00) from unutilized training expenses of various offices is hereby reverted to unappropriated balance, and appropriating the same to Barangay Support Fund under Special Purpose Appropriations (SPA) to fund the Barangay Performance Incentive (BPI) of barangay officials;
