ORDINANCE NO. 2018-014

AN ORDINANCE TEMPORARILY WITHDRAWING FROM PUBLIC SERVITUDE PORTION OF GENERAL LUNA AND ELIAS ANGELES STREETS SURROUNDING PLAZA RIZAL FROM AUGUST 15 TO SEPTEMBER 30, 2018, AND GRANTING THE NDC MANAGEMENT EVENT A PERMIT TO HOLD A TRADE FAIR THEREON FROM AUGUST 15 TO SEPTEMBER 30, 2018, SUBJECT TO CERTAIN TERMS AND CONDITIONS: -

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - The portions of General Luna and Elias Angeles Streets surrounding Plaza Rizal specifically identified in the attached plan, are hereby temporarily withdrawn from public servitude, and the NDC Management Event is hereby granted a permit to hold a Trade Fair thereon from August 15 to September 30, 2018, subject to the following terms and conditions:

- 1. That the period of the Trade Fair shall be from August 15 to September 30, 2018, provided that the payment of tax and fees thereof shall be paid on or before August 1, 2018;
- 2. The cleanliness, orderliness and peace and order in the area shall be maintained during the entire event to preserve the sanctity of Plaza Rizal;
- 3. That no pirated products shall be sold;
- 4. Sleeping and cooking in area are strictly prohibited;
- 5. No stalls shall be installed six (6) meters away from any corner of street;
- 6. That no stall shall occupy the sidewalks surrounding Plaza Rizal;
- 7. That all stalls shall be facing Plaza Rizal;
- 8. That this permit shall be revoked for any violation of the terms and conditions herein specified.

SECTION 2. - This ordinance shall take effect upon its approval.
