**AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE EXCESS APPROPRIATION FOR OTHER GENERAL SERVICES AND ENVIRONMENTAL/SANITARY SERVICES (ESS) FROM VARIOUS OFFICES AMOUNTING ONE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND ONE HUNDRED NINETY TWO PESOS (P1,583,192.00), AND APPROPRIATING THE SAME TO OTHER GENERAL SERVICES OF VARIOUS OFFICES TO COVER THE SALARY OF JOB ORDER AND CONTRACTUAL EMPLOYEES OF THE CITY GOVERNMENT :-**




