## ORDINANCE NO. 2019-005

AN ORDINANCE IMPLEMENTING THE FOURTH TRANCHE COMPENSATION ADJUSTMENT FOR COMPONENT CITIES RETROACTIVE TO JANUARY 1, 2019, FOLLOWING THE SALARY SCHEDULE FOR SECOND COMPONENT CITIES AS PROVIDED UNDER ANNEX A-2 OF LOCAL BUDGET CIRCULAR NO. 118 ISSUED ON JANUARY 15, 2019 BY THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) :-
