AN ORDINANCE REVERTING TO UNAPPROPRIATED BALANCE THE AMOUNT OF TWO MILLION ONE HUNDRED THOUSAND PESOS (P2,100,000.00) FROM 2018 CAPITAL OUTLAY ACCOUNT (ICT EQUIPMENT) OF THE OFFICE OF THE CITY ASSESSOR, AND APPROPRIATING THE SAME TO THE SPECIAL PROGRAM FOR EMPLOYMENT OF STUDENTS (SPES) OF THE METRO PESO:-
