AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 2016-042, ENTITLED: "AN ORDINANCE GRANTING A STIPEND OF FIVE THOUSAND PESOS (P5,000.00) EVERY NAGA CITY VETERANS DAY AND ARAW NG KAGITINGAN TO EVERY SURVIVING VETERAN OF THE PHILIPPINE-AMERICAN WAR, WORLD WAR II, AND THE KOREAN CAMPAIGN", BY INCREASING THE STIPEND FROM FIVE THOUSAND PESOS (P5,000.00) TO TEN THOUSAND PESOS (P10,000.00):-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. Section 3 of Ordinance No. 2016-042, entitled: "An ordinance granting a stipend of Five Thousand Pesos (P5,000.00) every Naga City Veterans Day and Araw ng Kagitingan to every surviving veteran of the Philippine-American War, World War II, and the Korean Campaign", by increasing the stipend from Five Thousand Pesos (P5,000.00) to Ten Thousand Pesos (P10,000.00), now to read as follows:

"SECTION 3. Stipend - The amount of **Ten Thousand Pesos (P10,000.00)** shall be granted to very surviving veteran of the Philippine-American War, World War II, and the Korean Campaign as stipend on the twin occasion of the observance of the Naga City War Veteran's Day on April 8 and the nationwide Araw ng Kagitingan on April 9 each year."

SECTION 2. This ordinance shall take effect upon its approval.
