**ORDINANCE INSTITUTIONALIZING THE SUMMER EMPLOYMENT FOR ENROLLMENT PROGRAM, DESIGNATING METRO NAGA PUBLIC EMPLOYMENT SERVICE OFFICE (METRO PESO) AS THE IMPLEMENTING OFFICE OF THE PROGRAM, AND ALLOCATING FUNDS FOR THE PURPOSE:-**

**BE IT ORDAINED** by the 12<sup>th</sup> Sangguniang Panlungsod of Naga, in session duly-assembled, that:

**Section 1.- Short Title.** This ordinance shall be known, for brevity, as "Summer Employment for Enrollment (SEFE) Ordinance."

**Section 2.- Summer Employment for Enrollment Program.** The Summer Employment for Enrollment (SEFE) Program is hereby institutionalized to help students in Senior High School and college, who are poor but deserving, to have a source of employment every summer and gain needed funds for payment of tuition and other academic fees comes the opening of classes. Every student-beneficiary shall work for 20 days in the City Government of Naga, with a compensation of not lower than the regional minimum wage rate.

**Section 3.- Priority to son/daughter of Solo Parent.** Qualified son/daughter of a Solo Parent shall be given a priority provided that only one will be accommodated if more than one from the family applied for the program.

**Section 4.- PWD or son/daughter of PWD.** Qualified Person with Disability (PWD) or son/daughter of a PWD shall be accommodated provided that the salary will be charged to the PWD Fund.

**Section 5.- Accident Insurance.** For ensuring the safety and welfare of the student-beneficiaries, an accident insurance shall be procured for each of the beneficiary, in coordination with Government Service Insurance System or any reputable insurance company.

**Section 6.- Implementing Office.** The Metro Naga Public Employment Service Office (METRO PESO) shall be in charge in implementing the provisions of this ordinance.

**Section 7.- Appropriation.** The amount of not less than Two Million Five Hundred Thousand Pesos (P 2,500,000.00) is hereby allocated in the annual budget under the account of Metro Peso for implementation of the Summer Employment for Enrollment (SEFE) Program.


