AN ORDINANCE AMENDING ORDINANCE NO. 2020-046, ENTITLED: "AN ORDINANCE INSTITUTING MEASURES TO PROMOTE PUBLIC HEALTH, SAFETY AND PROTECTION AGAINST THE CONTINUING THREAT OF COVID-19 OR ANY SUCH EMERGING INFECTIOUS DISEASES, IMPOSING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES", SPECIFICALLY SECTION 10 THEREOF BY CHANGING THE CURFEW HOUR:-

EXPLANATORY NOTE

WHEREAS, one of the measures adopted by the City Government of Naga to contain the spread of COVID 19 Pandemic is the passage of Ordinance No. 2020-046, imposing a curfew in the of Naga from 9 pm to 5 am.

WHEREAS, on July 17, 2020, Secretary Ramon Lopez of the Department of Trade and Industry issued Memo Circular No. 20-39, Increasing the Operating Capacity of Dine-In Food Establishment, allowing dine in establishments to operate until 11 o'clock in the evening, and enjoining LGU's to adjust curfew hours up to 12 midnight.

WHEREAS, based on said DTI Memo Circular, the Metro Naga Chamber of Commerce and Industry has requested the City Government of Naga, thru the Sangguniang Panglungsod to amend Ordinance No. 2020-046, to conform with the latest issuance of the DTI, and allow restaurant, fastfoods, and other dine in establishment to operate until 11 o'clock in the evening.

Thus, said request is meritorious because it is based on a national issuance.

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1. - Ordinance No. 2020-046, entitled: "An ordinance instituting measures to promote public health, safety and protection against the continuing threat of COVID-19 or any such emerging infectious diseases, imposing penalties for violation thereof, and for other purposes", is hereby amended specifically Section 10 thereof by changing the curfew hour, now to read as follows:

Naga City

"SECTION 10. Imposition of New Curfew Hours. As a further measure to achieve the purpose of this Ordinance, curfew hours from **12:00 midnight** to 4:00 o'clock a.m. is hereby imposed upon all persons within the territorial jurisdiction of the City of Naga.

10.1 During curfew hours, no person shall be in a public place such as streets, alleys, parks and plazas, playgrounds, subdivision open spaces, subdivision roads, buildings and facilities where no legitimate business is normally transacted at nighttime, or in vacant/idle lot, or vacant/abandoned buildings/structures.

10.2 To facilitate the observance of curfew hours, businesses which are normally open only for a fixed period per day shall open only after 4:00 o'clock a.m. and close not later than 12:00 midnight. Businesses which are normally open 24/7 or even at night shall ensure that they do not serve as refuge for curfew violators."

SECTION 2. - This Ordinance shall take effect immediately upon its approval and publication in a newspaper of general circulation in Naga City.


