ORDINANCE NO. 2020-105

AN ORDINANCE PROHIBITING THE CONDUCT OF CAROLING ALONG CITY STREETS, ROADS AND ON BOARD OF ANY KIND OF VEHICLE IN THE CITY OF NAGA AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF: -

EXPLANATORY NOTE

Under Section 13, Article II of the 1987 Constitution, the state recognize the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being.

Further, Under Section 3 (2), Article XV of the same law, the state shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their developments.

Moreover, there were observations of children conducting a caroling activities along city streets and even in moving public utility vehicles that endangers not only their well-being but the drivers and passengers of the PUVs as well.

Hence this ordinance is proposed for enactment to protect and ensure the welfare of the children.

Be it ordained, therefore, by the Sangguniang Panlungsod of Naga, that:

SECTION 1. PROHIBITION. It is hereby prohibited for the children to conduct caroling activities along city streets, roads and on board of any kind of vehicle in the City of Naga;

SECTION 2. PENALTIES. - The following penalties shall be imposed for violation of this ordinance:

First Offense:

Reprimand;

Second Offense:

Four Hours of Community Service to be rendered by the Parent in

his/her barangay;

Third and

Succeeding Offense: A fine of ₱1,000.00 or Eight

Hours of Community Service to be rendered by the Parent in

his/her barangay.
