

immediate restoration of electrical supply of affected areas under the guidance of the City Mayor and in coordination with CASURECO II, especially after the occurrence of calamities and disasters;


- (b) To actively participate and ensure full cooperation among its members in all city and barangays activities;

4.3 Functions of the LBO

- (c) To coordinate affairs, including the conduct of a continuing education seminar or skills training for the members of OBEN;
- (d) To provide members a venue for constructive discussion of the needs and problems affecting them and the people they serve;
- (e) To recommend plans and programs, in coordination with the Punong Barangays and subject to the approval of the City Mayor and implement the same for the welfare of all Barangay Electricians.

SECTION 5. - Continuing Education and Training. - To ensure that barangay electricians are conversant with the existing rules, regulations and technicalities, the Lingkod Barangay Office, Building Maintenance Office and other concerned government agencies/offices shall design and initiate skills trainings and capacity-building programs that a barangay electrician needs in the performance of duties and functions vital to their individual and collective performance. This is in coordination with the Institute of Integrated Electrical Engineers (IIEE) and other safety practitioners. The LBO and BMO shall coordinate with CASURECO II to establish accreditation mechanisms of barangay electricians. This accreditation shall be made as basis for recommendation to the respective Punong barangays for their subsequent hiring as barangay electricians.

SECTION 6. - Appropriations. - The Lingkod Barangay Office shall incorporate in its annual budget the necessary amount for the expenses of the organization, continuing education and training and for the implementation of this

ordinance, which shall be no less than Two Hundred Fifty Thousand Pesos (P250,000.00), starting this year and every year thereafter.

SECTION 7. - Separability Clause. - Any provision or portion of this ordinance found to be unconstitutional or invalid shall not impair the other provisions or parts thereof which shall continue to be in force and effect.

SECTION 8. - Repealing Clause. - Any or all ordinance, rules and regulations which are inconsistent or in conflict with the provision of this ordinance are hereby repealed and modified accordingly.

SECTION 9. - This ordinance shall take effect upon its approval.


