ORDINANCE NO. 2021-024

AN ORDINANCE AMENDING ORDINANCE NO. 2021-015, ENTITLED: "AN ORDINANCE MODIFYING THE POSITION TITLES OF NURSES POSITIONS IN THE CITY GOVERNMENT OF NAGA, AND ADJUSTING THEIR SALARY GRADES IN COMPLIANCE WITH R.A. 9173 AS IMPLEMENTED BY BUDGET CIRCULAR NO. 2020-4", BY CHANGING THE EFFECTIVITY UNDER SECTION 4 THEREOF:-

Be it ordained by the Sangguniang Panlungsod of Naga, that:

SECTION 1- Ordinance No. 2021-015, entitled: "An ordinance modifying the position titles of nurses positions in the City Government of Naga, and adjusting their salary grades in compliance with R.A. 9173 as implemented by Budget Circular No. 2020-4", is hereby amended by changing the effectivity under Section 4 thereof, now to read as follows:

"SECTION 1. - The position of Nurse 1 in the City Government of Naga is hereby adjusted from Salary Grade 11 to Salary Grade 15, in compliance with R.A. 9173 as implemented by Budget Circular No. 2020-4;

SECTION 2. In compliance with the said Budget Circular no. 2020-4, the position attributes of Nurses positions in the City Government of Naga, shall now be as follows:

From Nurse II - SG 15 to Nurse I - SG 15 From Nurse III - SG 17 to Nurse II - SG 17 From Nurse IV - SG 19 to Nurse III - SG 19 From Nurse V - SG 20 to Nurse IV - SG 20 From Nurse VI - SG 22 to Nurse V - SG 22

SECTION 3. - The appropriation to cover the adjustment in Salary, particularly with Nurse I position, shall be charged against the respective CY 2021 Budgets of the offices concerned.

SECTION 4. - This ordinance shall take effect January 1, 2021."

SECTION 2. - This ordinance shall effect upon its approval.
