WHEREAS, the entire country is now having serious concerns on the adverse effect of the Oil Deregulation Law that allows oil companies to freely adjust the prices of oil products that led to the increase in prices of prime commodities resulting to economic crisis;

WHEREAS, due to the Oil Deregulation Law, reports on profiteering is prevalent particularly in the countryside because of overpricing of fuel products by unscrupulous oil firms to the disadvantage of the consumers;

WHEREAS, given its magnitude effect to the Philippine economy, almost all sectors of the community are clamouring for the review of the Oil Deregulation Law in order for the government to protect and save the helpless consumers from the sky rocketing prices of fuel products;

WHEREAS, the immediate review of the Oil Deregulation Law was even supported by no less than His Excellency President Benigno Simeon C. Aquino III to save the country and the Filipino people from economic crisis caused by the ever-increasing prices of oil products;
