**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the 1<sup>st</sup> Indorsement dated December 6, 2010 from His Honor, the City Mayor, endorsing the letter of Mr. James John L. Manubay, Operator, Naga City Integrated Northbound Jeepney Terminal, resolving issues on terminal rate base on the demands of the majority of drivers to pay P36.00 per day without 10% rebate;

**WHEREAS**, on November 23, 2010, upon request of Mr. Manubay, the Sangguniang Panlungsod adopted Resolution No. 2010-387 approving his application for increase in terminal fees;

**WHEREAS**, during the Committee Hearing of the Committee on Public utilities on January 14, 2011, the terminal operator agreed to the request of the majority of officers and members of the concerned transport group to just pay a terminal fee in the amount of P36.00 per day without 10% rebate;

**WHEREAS**, finding the same to be in order and mutually agreed upon by both parties;

**NOW, THEREFORE**, on motion of Hon. Raoul T. Rosales, seconded by Hon. Cecilia V. De Asis, Hon. Salvador M. del Castillo and Hon. Jose A. Tuason;

**BE IT RESOLVED**, as it is hereby resolved, to amend Resolution No. 2010-387, entitled: "Resolution approving the application of Mr. James L. Manubay of the Naga City Integrated Northbound Jeepney Terminal for increase in terminal fees", by changing the terminal rate at the Naga City Integrated Northbound Jeepney Terminal at Thirty Six (P36.00) Pesos per day without 10% rebate.
