WHEREAS, on December 7, 2010 the Sangguniang Panlungsod enacted Ordinance No. 2010-063 otherwise known as City's Tertiary Scholarship Program (NTSP);

WHEREAS, Section 18 of the ordinance mandated all twenty Seven (27) barangays in the City to have their own Tertiary Scholarships Program which may be availed of by poor and deserving students in their respective barangays and that in furtherance thereof each barangays had allocated the fund required by the ordinance;

WHEREAS, meanwhile that necessary mechanisms have yet to be put in place and considering that the school year is already about to start, there is an urgent need to organize a Scholarship Screening Committee in each and every barangays which shall have the task of pre-qualifying and determining qualifications of the applicants to the program;

NOW, THEREFORE, on joint and collective motion of the Members of the 10th Sangguniang Panlungsod of the City of Naga;

BE IT RESOLVED, as it is hereby resolved, to direct the Sangguniang Barangay of the City's twenty seven (27) barangays to create a **Scholarship Screening Committee** which will pre-qualify and determine their respective barangays scholars to be composed of the following:
