**RESOLUTION ENJOINING ALL LIGA NG MGA BARANGAYS IN THE PHILIPPINES TO FAVORABLY SUPPORT SENATE BILL NO. 1323, ENTITLED: "AN ACT PROVIDING RETIREMENT BENEFITS FOR THE PUNONG BARANGAY AND THE MEMBERS OF THE SANGGUNIANG BARANGAY WHO HAVE SERVED THREE CONSECUTIVE TERMS AS SUCH OFFICIALS":-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is a copy of Resolution No. 105 of the Sangguniang Panlungsod of Zamboanga supporting, among others, Senate Bill No. 1323, entitled: "An Act Providing Retirement Benefits for the Punong Barangay and the Members of the Sangguniang Barangay who have Served Three Consecutive Terms as such Officials";

**WHEREAS**, the Local Government Code tasks the Punong Barangay and the Sangguniang Barangay with primary function of ensuring the general welfare of the barangay and its inhabitants;

**WHEREAS**, working almost 24 hours a day, seven days a week, the Punong Barangay and the Members of the Sangguniang Barangay receive only honoraria and other benefits, however, the law does not provide for their pension when they retire;

**WHEREAS**, this Bill seeks to address the need by providing for pension benefits for the Punong Barangay and the Members of the Sangguniang Barangay when they retire particularly those who have served at least three (3) consecutive terms as such barangay official;

**WHEREAS**, finding the same to be in order and beneficial to the Punong Barangays and Members of the Sangguniang Barangay who have served three consecutive terms;

**NOW, THEREFORE**, on motion of Hon. Alex C. Nero, seconded by Hon. Jose A. Tuason and Hon. David Casper Nathan A. Sergio;

**BE IT RESOLVED**, as it is hereby resolved, to enjoin all Ligangmga Barangays in the Philippines to favorably support Senate Bill No. 1323, entitled: "An Act Providing Retirement Benefits for the Punong Barangay and the Members of the Sangguniang Barangay who have Served Three Consecutive Terms as such Officials".
