RESOLUTION DECLARING UNDER THE STATE OF CALAMITY THE BARANGAYS TRIANGULO, TABUCO, MABOLO, SABANG AND IGUALDAD IN THE CITY OF NAGA DUE TO CONTINUOUS FLOODING IN THE AFTERMATH OF TYPHOON "JUANING" THAT HIT THE CITY ON JULY 26, 2011:-

On joint and collective motion

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated August 1, 2011 of His Honor, the City Mayor, requesting for the passage of a resolution declaring the city under the State of Calamity due to Typhoon "Juaning" that hit the city last July 26, 2011;

**WHEREAS**, several days after the city was hit by Typhoon "Juaning", it was observed that Barangays Triangulo, Tabuco, Mabolo, Sabang and Igualdad which are identified as low-lying areas in the city, remain affected by flood waters that continuously brought hardships to residents, and damages to properties;

**WHEREAS**, given such situation in the area, the city government has initiated medical missions and relief operations to assist the affected families;

**WHEREAS**, finding the declaration of State of Calamity in the affected barangays to be in order and necessary to effectively assist the affected families;

**NOW, THEREFORE**, on joint and collective motion of the Members of the 10<sup>th</sup> Sangguniang Panlungsod of the City of Naga;

**BE IT RESOLVED**, as it is hereby resolved, to declare under the State of Calamity the Barangays Triangulo, Tabuco, Mabolo, Sabang and Igualdad in the City of Naga due to continuous flooding in the aftermath of Typhoon "Juaning" that hit the city on July 26, 2011.
