RESOLUTION AMENDING RESOLUTION NO. 2010-340, BY ADDING THE WORD "SENIOR CITIZENS" ON THE TITLE THEREOF, NOW TO READ AS FOLLOWS: "RESOLUTION CREATING AN INTER-AGENCY MECHANISM ON IMPLEMENTATION OF R.A. 9994, OTHERWISE KNOWN AS THE "EXPANDED SENIOR CITIZENS ACT OF 2010", WHICH SHALL BE CALLED AS THE "NAGA CITY SENIOR CITIZENS COORDINATING AND MONITORING BOARD (NCSCCMB)", DEFINING ITS COMPOSITION, DUTIES AND FUNCTIONS":-

**WHEREAS**, the Implementing Rules and Regulation (IRR) of R.A. 9994 establishes an Inter-agency Mechanism in national and regional levels, called the National Coordinating and Monitoring Board (NCMB) and Regional Coordinating and Monitoring Board (RCMB), respectively, composed of government agencies, Non-Government Organization and People's Organization;

**WHEREAS**, the function of the Board is to coordinate, monitor, and evaluate the implementation of the programs and projects and to prepare yearly accomplishment reports;

**WHEREAS**, Section 5 of Article 25, of IRR Rule VIII, encourages, if practicable, the establishment of similar body in the local level;

**NOW, THEREFORE**, on motion of Hon. Jose A. Tuason, duly seconded by Hon. Esteban R. Abonal;

**BE IT RESOLVED**, as it is hereby resolved, to amend Resolution No. 2010-340 by adding the word "Senior Citizens" on the title thereof, now to read as follows: "Resolution creating an Inter-Agency Mechanism on Implementation of R.A. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010", which shall be called as the "Naga City Senior Citizens Coordinating and Monitoring Board (NCSCCMB)", with the following composition, duties and functions:

- a) The NCSCCMB shall be composed of the following:
  - Chairman-Social Welfare and Development Officer
  - Vice-Chairman- DILG City Director
  - Members: Head of the Office for Senior Citizens Affairs;
  - City Legal Officer
  - City Health Officer
  - DTI City Field Officer
  - A representative from accredited NGO and PO's
  
- b) The NCSCCMB shall have the following duties and functions:

- 1) To formulate a City Plan of Activities for Senior Citizens, in coordination with the City Government, the Social Welfare and Development Office and Stakeholders;
  - 2) To develop an effective monitoring and reporting system towards efficient and uniform implementation of the law;
  - 3) To develop and institute effective and innovative approaches and methods to address emerging concerns of the senior citizens;
  - 4) To coordinate the programs and projects of the City Government with responsibilities under R.A. No. 9994 and the Implementing Rules and Regulations;
  - 5) To monitor the conduct of orientation, training and other capability building programs to maximize the contributions and participation of the senior citizens;
  - 6) To coordinate the conduct and evaluation of the plan of action, research and documentation of good practices and disparities for policy and program development; and
  - 7) To prepare yearly report for the Office of the City Mayor and concerned local government units.
- c) The **NCSCCMB** shall be provided by the City Government with reasonable budget for its operation and implementation of its functions;
- d) The members of the **NCSCCMB** shall meet quarterly to promulgate policies, rules and regulations, and resolve issues, complaints and other concerns related to senior citizens affairs;
- e) The Members shall be reimbursed of whatever expenses they incur in the performance of their duties;
- f) The Office for Senior Citizens Affairs (OSCA) shall serve as the Secretariat, **and shall provide snacks during its quarterly meeting and other supplies needed.**
