RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE WITH THE HEIRS OF EDDIE ALANIS, ET.AL., REPRESENTED BY MARIA DELEGADA ALANIS-BRENDIA, CO-OWNER AND ATTORNEY-IN-FACT, FOR THE POSSIBLE ACQUISITION OF THEIR PROPERTY LOCATED AT BARANGAY CONCEPCION PEQUEÑA, NAGA CITY, SPECIFICALLY DESIGNATED AS LOT NO. 1115, COVERED BY TCT NO. 20221 WITH AN AREA OF 62,189 SQUARE METERS, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-
