LAVADIA, JR. OF THE SAME BARANGAY, ON THE PREMISE THAT THE SAID COMPLAINT-AFFIDAVIT IS NOT VERIFIED AND INSUFFICIENT IN FORM:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the copy of Legal Opinion No. 2012-006 dated February 9, 2012 of the City Legal Officer with respect to the Complaint-Affidavit dated January 4, 2012 signed by Mario Moreno, Julita Abutin, Carmen Rosero, Treasurer, Socorro Zamudio, Fe Roldan, Alfredo Bongalbal, Aida Tesorero, Jose Llagas, Ernesto Amelano, Rodolfo Sanchez, Leonora San Joaquin, Oscar Rodriguez and Herminio Dura who are Executive Officers and Members of the Board of Directors of the Barangay Association of Senior Citizens Affairs (BASCA) of Tabuco, this city, against P/Bgy. Lavadia, Jr. of the same barangay, on the premise that the said complaint-affidavit is not verified and insufficient in form.
