RESOLUTION DENYING THE PROPOSED TRANSFER OF ELECTRONIC GAMES (E-GAMES) OF MR. CARLOS C. GO TO REGENT HOTEL II, BESIDE THE BARANGAY HALL OF DINAGA AND UNLIFE CORPORATION DUE TO THE EXISTING EDUCARE CENTER IN THE AREA WITHOUT PREJUDICE FOR THE APPLICANT TO LOOK FOR OTHER VENUES COMPLIANT WITH ORDINANCE NO. 2010-048:-

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated February 10, 2012 of Mr. Carlos C. Go specifying the exact location of his proposed-Games at Regent Hotel II, beside the Barangay Hall of Dinaga and Sunlife Corporation in compliance with the advice of the Office of the City Engineer to look for another venue that would comply with the requirements of Ordinance No. 2010-048;

**WHEREAS**, information revealed that near the proposed location of E-Games Operation, is an existing EDUCARE Center in the area;

**WHEREAS**, Section 6 (a) of Ordinance No. 2010-048 provides that:

"(a) On Location and Distance -

No Egames venue shall be established or allowed to operate within Three Hundred (300) meters from any place of worship or learning, except if the site is within a shopping center or enclosed structure hidden from the view of people outside thereof."

**NOW, THEREFORE**, on motion of Hon. Ray-An Cydrick G. Rentoy, seconded by Hon. Maria Elizabeth Q. Lavadia;

**BE IT RESOLVED**, as it is hereby resolved, to deny the proposed transfer of Electronic Games (E-Games) of Mr. Carlos C. Go to Regent Hotel II, beside the Barangay Hall of Dinaga and Sunlife Corporation due to the existing EDUCARE Center in the area without prejudice for the applicant to look for another venue compliant with Ordinance No. 2010-048.
