RESOLUTION DECLARING THE CITY OF NAGA UNDER THE STATE OF CALAMITY DUE TO DENGUE OUTBREAK BASE ON THE REPORT OF THE CITY EPIDEMIOLOGY AND SURVEILLANCE UNIT OF THE CITY HEALTH OFFICE:-

On joint and collective motion

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated May 17, 2012 of the City Epidemiology and Surveillance Unit of the City Health Office with respect to the update on Dengue Cases in the city from the period January 1 to May 16, 2012;

WHEREAS, in open session, the City Health Officer, Dr. Vito C. Borja II, reported that there is a dramatic increase of 91.77% in dengue cases in the city as compared to same period of last year, although no fatality was reported;

WHEREAS, report further shows that dengue incidents are recorded in 24 out of 27 barangays of the city with a total of 303 cases;

WHEREAS, the City Health Officer projected that there is a possibility that dengue cases in the city may continue to increase given the opening of classes this June;

WHEREAS, given the magnitude of its effect, and the necessity to immediately address and prevent further increase of dengue cases in the city, it is imperative that the entire city be declared under the State of Calamity;

NOW, THEREFORE, on joint and collective motion of the Members of the 10th Sangguniang Panlungsod of the City of Naga;

BE IT RESOLVED, as it is hereby resolved, to declare the City of Naga under the State of Calamity due to dengue outbreak base on the report of the City Epidemiology and Surveillance Unit of the City Health Office;
