RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE WITH FPM CORPORATION THROUGH MR. FORTUNATO MENDOZA TO WAIVE SOME OF ITS RIGHT UNDER THE LEASE MANAGEMENT AGREEMENT, AND TO ALLOW THE TRANSFER OF GENOVA AND EUG TRANSPORT UNITS PLYING CABUSAO VIA LIBMANAN-NAGA ROUTE AND VICE VERSA FROM THE NAGA CITY CENTRAL BUS TERMINAL TO LCC TERMINAL IN BARANGAY SABANG, NAGA CITY:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated June 7, 2012 from the Office of the City Mayor, indorsing Resolution No. 2012-19 of Libmanan Transport Service Cooperative (LIBTRASCO), requesting for the immediate transfer of terminal assignment of the Genova and EUG Transport Units plying Cabusao-Libmanan-Naga route and vice versa from the Naga City Central Bus Terminal to LCC Terminal at Sabang, Naga City;

WHEREAS, this intent of the LIBTRASCO to transfer its transport units from the Naga Central Bus Terminal to LCC Terminal in Barangay Sabang, this city, is compliant to Ordinance No. 2010-044;

WHEREAS, the said proposed transfer is deemed necessary considering the observations that some passenger buses can no longer be accommodated in the Central Bus Terminal as manifested by the presence of buses parked on roadsides within the terminal premises;

WHEREAS, finding the same to be in order;

NOW, THEREFORE, on motion of Hon. Nelson S. Legacion, seconded by Hon. David Casper Nathan A. Sergio and Hon. Esteban R. Abonal;

BE IT RESOLVED, as it is hereby resolved, to authorize HIS HONOR, the City Mayor to negotiate with FPM Corporation through Mr. Fortunato Mendoza to waive some of its right under the Lease Management Agreement, and to allow the transfer of Genova and EUG Transport Units plying Cabusao via Libmanan-Naga Route and vice versa from the Naga City Central Bus Terminal to LCC Terminal in Barangay Sabang, Naga City.
