INC., THE MANAGEMENT AND MAINTENANCE OF TENNIS COURT NO. 3 AT
THE NAGA CITY CIVIC CENTER, AND ALLOCATING THE SAME FOR
EXCLUSIVE USE OF THE NAGA CITY GOVERNMENT:-

On joint and collective motion

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter-complaint dated November 22, 2012 of Ms. Jeanette Mae S. Gagalac bringing to the attention of the city government the incident involving "An Maogmang Lugar" Tennis Club, Inc. and the young athletes and their parents over the use of the tennis courts in the Naga City Civic Center;

WHEREAS, in his letter dated January 23, 2013, Mr. Bryan Bonifacio L. Cu, President, "An Maogmang Lugar" Tennis Club, Inc. stressed that the complaint of Ms. Gagalac is directed only to two (2) club members and not against the entire club membership, and the same complaint was prematurely brought to the concerned offices instead of bringing the same first before the club's leadership;

WHEREAS, the tennis courts are located within the Naga City Civic Center and the same is considered as a city property, and considering further that in the absence of any Contract, the city government has the right over the use and management thereof;

WHEREAS, finding the same to be in order and necessary to accommodate and develop potential tennis players in the city, the Naga City Government withdraws from "An Maogmang Lugar" Tennis Club, Inc. the management and maintenance of Tennis Court No. 3 at the Naga City Civic Center;

NOW, THEREFORE, on joint and collective motion of the Members of the 10th Sangguniang Panlungsod of the City of Naga;
