RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REGIONAL OFFICE NO. 5, LEGASPI CITY, RELATIVE TO THE IMPLEMENTATION OF DILG'S "2013 SAGANA AT LIGTAS NA TUBIG SA LAHAT PROGRAM" OR "SALINTUBIG" IN THE CITY OF NAGA, SUBJECT TO THE RATIFICATION BY THE SANGGUNIANG PANLUNGSOD:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated February 8, 2013 of His Honor, the City Mayor, requesting for the passage of a resolution authorizing him to enter into a Memorandum of Agreement with the Department of the Interior & Local Government (DILG) with respect to the approved Bottom-up Budgeting (BUB) Project through DILG's "2013 Sagana at Ligtasna Tubig sa Lahat Program" or "SALINTUBIG" which provides financing and capability development programs for the implementation of water supply projects in waterless cities and municipalities;

WHEREAS, one of the requirements for the release of funds in the amount of P2.5 Million is a Sanggunian resolution authorizing the Local chief Executive to enter into a Memorandum of Agreement with the DILG Regional Office No. V, Legaspi City;

WHEREAS, the City of Naga has been identified by the National Anti-Poverty Commission (NAPC), the Department of Social Welfare & Development (DSWD), the Department of the Interior & Local Government (DILG), and Department of Budget & Management (DBM) as one of the Bottom-up Budgeting (BUPB) priority areas and had complied with all the requirements through the endorsement of its Local Poverty Reduction Action Plan (LPRAP) by the Business Sector (BS)/Civil Society Organizations (CSO);
