RESOLUTION TO UNDERTAKE CODIFICATION PROJECT AND TO CREATE FOR SAID PURPOSE THE CODIFICATION COMMITTEE AND TECHNICAL WORKING GROUP:-

WHEREAS, the 11th Sangguniang Panlungsod commits to a responsive and efficient enactment of ordinances in Naga City;

WHEREAS, codification of city ordinances by sector or by topic is a laudable initiative which can provide the city officials and the citizenry of Naga a clear, up-to-date and comprehensive copy of all enacted ordinances for convenient reference of city officials and citizenry;

WHEREAS, by codifying the city's ordinances, it will be easier for legislators to pose necessary amendments or required addenda, thus ensuring that its policies are timely and relevant to present circumstances of the city;

WHEREAS, by having a code per sector or per subject, there will be increase in the public's awareness on the various programs and policies, thus, enabling them to maximize the uses of their privileges and, consequently, utilize such to improve their socio-economic status;

WHEREAS, in recognition of the importance of codes to effective and responsive legislation, the 11th Sangguniang Panlungsod should engage into a project that aims to consolidate and codify the various ordinances of the City of Naga;

WHEREAS, a codification committee is necessary to provide direction and guidance and a technical committee implement the project thereby realizing the vision of the Sangguniang Panlungsod to codify its various ordinances;

NOW, THEREFORE, on motion of Hon. Elmer S. Baldemoro, duly seconded by Hon. Mila S.D. Raquid-Arroyo;

BE IT RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Naga shall undertake a Codification Project, an initiative which aims to consolidate and codify all ordinances of the City of Naga;
