RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF NAGA AND THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES (NHCP) RELATIVE TO THE TRANSFER OF THE AMOUNT OF TWO MILLION (P2,000,000.00) PESOS TO THE NAGA CITY GOVERNMENT TO COVER THE ENGINEERING AND ARCHITECTURAL DESIGN OF THE JESSE M. ROBREDO MUSEUM:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated March 31, 2014 from the Office of the City Mayor, endorsing for ratification the Memorandum of Agreement entered into by and between the City Government of Naga and the National Historical Commission of the Philippines for the transfer of P2 Million from the said Commission to the Naga City Government to fund the Engineering and Architectural Design of the Jesse M. Robredo Museum;

BE IT RESOLVED, as it is hereby resolved, to ratify the Memorandum of Agreement entered into by and between the City Government of Naga and the National Historical Commission of the Philippines (NHCP) relative to the transfer of the amount of Two Million (P2,000,000.00) Pesos to the Naga City Government to cover the Engineering and Architectural Design of the Jesse M. Robredo Museum.
