**BE IT RESOLVED**, as it is hereby resolved, to express the deep appreciation of the 11<sup>th</sup> Sangguniang Panlungsod to the 2014 City Youth Sangguniang Panlungsod for their active participation in the regular session, and encouraging them to continuously and actively participate in the future undertakings of the city government.
