# RESOLUTION APPROVING AND ADOPTING THE 10 YEAR SOLID WASTE MANAGEMENT PLAN OF NAGA CITY FOR THE YEAR 2012-2022:-

WHEREAS, long before the passage of Republic Act No. 9003 or the Ecological Solid Waste Management Act of 2000, Naga City has been committed in environment conservation and proper waste management and, in fact, has been continuously implementing innovative programs on effective and efficient solid waste management through the virtue of the following ordinances, among others: a) Ordinance No. 1971-383 or the Anti-Littering Ordinance, b) Ordinance No. 1974-427 or the New Garbage Code of the City of Naga; and c) Ordinance 1995-080 which establishes the Ecological Waste Management Program in the City of Naga;

WHEREAS, the enactment of Republic Act No. 9003 on January 26, 2001 strengthens and sets the direction of the City Government of Naga towards more aggressive implementation of environment conservation and solid waste management programs through an institutionalized people's participation in carefully crafted processes and mechanisms;

WHEREAS, pursuant to Republic Act No. 9003, the City Government of Naga, through the Solid Waste Management Board, is mandated to develop a City Solid Waste Management Plan that shall ensure the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of the barangays in its area of jurisdiction;

WHEREAS, months after the enactment of the aforementioned stature, the Sangguniang Panlungsod of Naga passed on October 3, 2001, Ordinance No. 2001-073 creating the Naga City Solid Waste Management Board (SWMB), defining its composition and functions, and providing funds for said purpose;

WHEREAS, under Ordinance No. 2001-073, a Support Secretariat to the Naga City Solid Waste Management Board was created and was primarily composed of the Staff Personnel from the Environment & Natural Resources Office (ENRO) which functions centered on providing technical and administrative assistance to the SWMB;

WHEREAS, on January 5, 2011, the Support Secretariat to the Naga City Solid Waste Management Board was elevated to a full pledged department into the Solid Waste Management Office;

WHEREAS, the Solid Waste Management Office together with the Solid Waste Management Board crafted a ten-year Solid Waste Management Plan covering the period 2012 to 2022;

WHEREAS, a large portion of the plan is the sustainment and further improvement of the good practices on solid waste collection and management, being implemented by the city way back the time of the late Interior Secretary and former Naga Mayor Jesse M. Robredo;

WHEREAS, proposed new programs incorporated in the Solid Waste Management Plan 2012-2022 are found to be sound and feasible by the Sangguniang Panlungsod of Naga;

WHEREAS, the Solid Waste Management Plan 2012-2022 is an essential guidebook that contains specific strategies and timetables on the implementation of the city's solid waste management programs;

WHEREAS, the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB)Regional Office V shall be furnished a copy of Naga City's Solid Waste Management Plan 2012-2022 for review and endorsement to the National Solid Waste Management Commission;
