RESOLUTION REQUESTING THE OFFICE OF THE DIVISION OF CITY SCHOOLS, DEPARTMENT OF EDUCATION, FOR THE IMMEDIATE INTEGRATION OF THE BIKOL/NAGA HISTORY IN THE APPROPRIATE CURRICULAR PROGRAMS OF ALL PUBLIC ELEMENTARY AND SECONDARY SCHOOLS IN THE CITY OF NAGA:-

Introduced by Councilor David Casper Nathan A. Sergio

WHEREAS, Section 16 of R.A. 7160 (1991 Local Government Code) mandates LGUs to ensure and support the preservation and enrichment of culture;

WHEREAS, written history, of which Bicol and Naga City is not wanting, forms part of our cultural heritage;

WHEREAS, the integration of local history in our educational system is one of those strategies mentioned in the Medium-Term Philippine Development Plan towards attaining the goal of institutionalizing culture in education and in good governance;

WHEREAS, integrating local history in our educational system will pave the way for a heightened sense of pride to anyone claiming to be a Bicolano or a Nagueño, through the narratives on the exploits and outstanding deeds of our local heroes;

WHEREAS, the Department of Education, through its City School's Division,, is empowered to facilitate integration of local history as part of the indigenization of the basic education curriculum;

NOW, THEREFORE, on motion of Councilor Nathan A. Sergio, duly seconded by Hon. Ray-An Cydrick G. Rentoy, Hon. Mila S.D. Raquid-Arroyo and Hon. Joaquin F. Perez, Jr.;

BE IT RESOLVED, as it is hereby resolved, to pass a resolution directing the Office of the Division of City Schools, Department of Education, for the immediate integration of the Bicol/Naga History in the appropriate curricular programs of all public elementary and secondary schools in the City of Naga.

FURTHER RESOLVED, to enjoin the City School Board to extend all the necessary financial and material support towards attaining the purpose of this Resolution.
