WHEREAS, a major fragment of Naga's history is the array of officials it has since its establishment as Municipality and eventually, City of Naga;

WHEREAS, the mayors, vice mayors and councilors who have served Naga since its inception as a municipality and eventually a city under the Republic of the Philippines have all inspired, led, motivated and influenced generations of Nagueños;

WHEREAS, these luminaries have been the catalysts of change, of inclusive and robust socio-economic development and of path breaking revolutions which have molded Naga as a *Maogmang Lugar*;

WHEREAS, building an Executive-Legislative Gallery which will feature the photos, names and accomplishments of all the former officials of Naga is an essential undertaking to preserve and promote Naga's history and culture;

BE IT RESOLVED, as it is hereby resolved, that the City Government of Naga commits to undertake the Executive-Legislative Gallery Project and construct a galleria which will feature the photos, names and accomplishments of the officials of Naga;
