RESOLUTION EARNESTLY REQUESTING THE CAMARINES SUR II  
ELECTRIC COOPERATIVE II (CASURECO II) THROUGH ITS OIC-  
GENERAL MANAGER, MR. ROLLY PANTE, TO PROVIDE THE CITY  
GOVERNMENT OF NAGA A TIMETABLE WITHIN WHICH TO FINISH THE  
RESTORATION OF POWER SUPPLY IN NAGA CITY AFTER THE  
DESTRUCTION WROUGHT BY TYPHOON GLENDA ON JULY 15, 2014:-

On joint and collective motion

**WHEREAS**, on July 15, 2014, the City of Naga was devastated by Typhoon Glenda leaving around 1,768 families homeless;

**WHEREAS**, Typhoon Glenda also brought heavy damages to properties, infrastructure, agriculture, and isolated the City of Naga and neighboring localities from power supply and telecommunication facilities;

**WHEREAS**, due to the magnitude of destruction wrought by Typhoon Glenda, the City of Naga was declared under the State of Calamity through SP Resolution No. 2014-216;

**WHEREAS**, it will be noted that the National Grid Corporation of the Philippines (NGCP) recently provided the power supply to CASURECO II;

**WHEREAS**, the Naga City Government will highly appreciate it if the Camarines Sur II Electric Cooperative could provide a timetable within which to complete the restoration of distribution lines in order to finally energize the City of Naga;

**NOW, THEREFORE**, on joint and collective motion of the Members of the 11<sup>th</sup> Sangguniang Panlungsod of the City of Naga;

**BE IT RESOLVED**, as it is hereby resolved, to earnestly request the Camarines Sur II Electric Cooperative II (CASURECO II) through its OIC-General Manager, Mr. Rolly Pante, to provide the City Government of Naga a timetable within which to finish the restoration of power supply in Naga City after the destructions wrought by Typhoon Glenda on July 15, 2014.
