RESOLUTION AMENDING RESOLUTION NO. 2014-151, ENTITLED: "RESOLUTION FAVORABLY ENDORSING TO THE PHILIPPINE ECONOMIC ZONE AUTHORITY (PEZA) TO DECLARE THE 2.2-HECTARE PORTION OF THE 6-HECTARE PROPERTY OF MR. ANTONIO G. DY-PRIETO, PRESIDENT & CEO, ALDP LAND AND CONSTRUCTION CORPORATION, LOCATED ALONG ROXAS AVENUE, NAGA CITY, AS A PEZA INFORMATION TECHNOLOGY PARK (IT PARK)", BY CHANGING THE AREA FROM 2.2 HECTARES TO 24,427 SQUARE METERS:-

Dy-Prieto, President and CEO, ALDP Land & Construction corp., acknowledging with thanks the prompt action of the Sangguniang Panlungsod for the passage of Resolution No. 2014-151, and requesting for amendment of the said resolution by specifically stating that the area of the proposed IT Park is 24,427 square meters instead of 2.2 hectares;

WHEREAS, this request for amendment in the area of the IT Park is necessary per review and recommendation of the Philippine Economic Zone Authority (PEZA) to consolidate the lots to facilitate the processing of the application for IT Park;

WHEREAS, finding the same to be in order and necessary;

BE IT RESOLVED, as it is hereby resolved, to amend Resolution No. 2014-151, entitled: "Resolution favorably endorsing to the Philippine Economic Zone Authority (PEZA) to declare the 2.2-hectare portion of the 6-hectare property of Mr. Antonio G. Dy-Prieto, President & CEO, ALDP Land and Construction Corporation, located along Roxas Avenue, Naga City, as a PEZA Information Technology Park (IT Park)", by changing the area from 2.2 hectares to 24,427 square meters.

LET COPIES of this resolution be furnished His Honor, the City Mayor for his concurrence, the Director General and Board of Directors of the Philippine Economic Zone Authority for their consideration and appropriate action, and Mr. Antonio G.
