**WHEREAS**, this week, the first week of March and every year thereafter, has been declared by the City Government of Naga as Electric Power Conservation Week;

**WHEREAS**, at the center of the celebration is the thrust of making Naga City sufficient in its electric power requirement to support the development needs of its people;

**WHEREAS**, it is indispensable in the quest for electric power sufficiency that the source thereof be assured;

**WHEREAS**, the City Government has already previously declared, per Resolution No. 2013-307, that in the pursuit of electric power sufficiency, the sources that shall be developed are those that are renewable in order to truly conserve and protect our natural resources;

**WHEREAS**, by way of leadership by example, it is urgent that the City Government of Naga now implement a scheme whereby its commitment for renewable power source shall be have been implemented, even initially and on a pilot scale;

**WHEREAS**, the City government of Naga is in receipt of offers from the private sector for possible partnership towards the subject direction;
