RESOLUTION URGENTLY AND EARNESTLY REQUESTING THE OFFICE OF THE CITY MAYOR TO IMPLEMENT THE RECOMMENDATIONS NECESSARY IN THE OPERATIONS OF THE TEMPORARY EASTBOUND (UV) VAN TERMINAL:-

WHEREAS, received by the Sangguniang Panlungsod for information is the Status Report on the Operations of the Temporary Eastbound (UV) Van Terminal at the Central Business District II (CBD II) submitted by Hon. Jose A. Tuason as Oversight Person of the terminal designated by the Sangguniang Panlungsod through Resolution No. 2015-062;

WHEREAS, contained in the said status report are the following recommendations:

1. Assignment of at least two (2) PNP Personnel 24/7;
2. Assignment of additional two (2) PSO personnel to augment security;
3. Assignment of two (2) SWMO personnel to maintain cleanliness;
4. Painting of the City Treasurer's Personnel Office be done, and the installation of additional lightings;
5. Occasional fogging be requested to drive away mosquitoes in the surroundings;
6. That all listed assigned personnel (CTO, PNP, PSO SWMO and others) in the area be furnished the CMO and SP for further checking.

WHEREAS, in the course of its deliberation, the Sangguniang Panlungsod further recommended the following measures to respond to some observations and reports, to wit:

- a. The comfort rooms shall be used for free, and the city government should assign personnel that will maintain its cleanliness;
- b. Barkers/Callers should be prohibited to avoid confusion for the riding public; and
- c. Additional two (2) PSO Personnel during rush hours.

WHEREAS, finding the said recommendations to be in order and necessary in the operation and management of the Temporary Eastbound Terminal;

NOW, THEREFORE, on motion of Hon. Jose A. Tuason, seconded by Hon. Gabriel H. Bordado Jr., Hon. Elmer s. Baldemoro and Hon. Mila S.D. Raquid-Arroyo;

BE IT RESOLVED, as it is hereby resolved, to urgently and earnestly request the Office of the City Mayor to implement the following recommendations necessary in the operations of the Temporary Eastbound (UV) Van Terminal, to wit:

1. Assignment of at least two (2) PNP Personnel 24/7;
2. Assignment of additional two (2) PSO personnel to augment security;
3. Assignment of two (2) SWMO personnel to maintain cleanliness;
4. Painting of the City Treasurer's Personnel Office be done, and the installation of additional lightings;
5. Occasional fogging be requested to drive away mosquitoes in the surroundings;
6. That all listed assigned personnel (CTO, PNP, PSO SWMO and others) in the area be furnished the CMO and SP for further checking;
7. The comfort rooms shall be used for free, and the city government should assign personnel that will maintain its cleanliness;
8. Barkers/Callers should be prohibited to avoid confusion for the riding public; and
9. Additional two (2) PSO Personnel during rush hours.
