WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Indorsement dated May 12, 2015 from the Office of the City Mayor, endorsing for confirmation and ratification the Memorandum of Agreement entered into by and between the Department of Environment and Natural Resources-Provincial Environmental and Natural Resources Office (PENRO) and the City Government of Naga relative to the Naga Riverbank Rehabilitation Project in Riverine Barangays and the National Greening Program: City Trees Development covering 19 hectares in Barangay Panicuason, Naga City;
