**RESOLUTION APPROVING THE ESTABLISHMENT OF PERMANENT NAGA CITY EASTBOUND UV EXPRESS AND PUJ TERMINAL ON A 5,000 SQUARE-METER PORTION OF THE 7,000 SQUARE-METER PROPERTY OF THE CITY GOVERNMENT LOCATED BESIDE THE JESSE M. ROBREDO COLISEUM: -**

**WHEREAS**, on April 7, 2015, the Sangguniang Panlungsod adopted Resolution No. 2015-100, declaring the possibility of utilizing the city government property in Central Business District II, triangulo, Naga City as the permanent Eastbound Public Utility Vans (PUVs) Terminal and creating a Technical Working Group (TWG) to study the matter and make its recommendation to the Sangguniang Panlungsod;

**WHEREAS**, on 10 July 2015, the said Technical Working Group (TWG) submitted to the Sangguniang Panlungsod for consideration, the Revised Pre-Feasibility Study on the Eastbound UV Express Terminal;

**WHEREAS**, in response to some concerns particularly on provision for parking, spatial suitability of the property for such purpose, and the legal question on whether the City Government can utilize the property for purposes other than housing, the Technical Working Committee submitted for the consideration of the Sangguniang Panlungsod the final result of the study conducted by it;

**WHEREAS**, based on the said final result, the concerns raised by the Sangguniang Panlungsod had been sufficiently responded to;

**WHEREAS**, based on the said final result of study conducted by the Technical Working Committee, the Sangguniang Panlungsod finds that the subject property can be appropriately utilized as the site of the permanent Eastbound UV Express and PUJ Terminal and necessary to achieve an orderly public transport system and to ensure the safety and convenience of the riding public;

**NOW, THEREFORE**, on motion of Hon. Mila S.D. Raquid-Arroyo, seconded by Hon. Elmer S. Baldemoro, Hon. Cecilia Veluz-De Asis and Hon. Vidal P. Castillo;
