

RESOLUTION NO. 2017-077

RESOLUTION APPROVING THE ANNUAL BUDGET OF BARANGAY PANICUASON, CITY OF NAGA FOR CALENDAR YEAR FROM JANUARY 1 TO DECEMBER 31, 2017 AS EMBODIED UNDER ORDINANCE NO. 003, SERIES OF 2016 INVOLVING THE AMOUNT OF TWO MILLION EIGHT HUNDRED NINETY SIX THOUSAND EIGHT HUNDRED FIFTY ONE PESOS (P2,896,851.00) IN CONFORMITY WITH EXISTING BUDGETARY RULES AND REGULATIONS AND IN ACCORDANCE WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991:-
