RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF NAGA AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REGION V (DPWH-BICOL) RELATIVE TO THE AMPHIBIOUS EXCAVATOR (AE6) THAT SHALL BE USED IN THE DREDGING AND SEDIMENTATION/SILTATION COLLECTION AT THE NAGA RIVER: -

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the 1st Endorsement, dated 7 April 2017, of His Honor, City Mayor John G. Bongat, endorsing for ratification the Memorandum of Agreement entered into by and between the City Government of Naga and the Department of Public Works and Highways Region V (DPWH-Bicol) with respect to the Amphibious Excavator (AE6) that shall be used in the dredging and sedimentation/siltation collection at the Naga River;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

The MEMORANDUM OF AGREEMENT made and executed by and between:

The **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS**, **REGION V**, represented by **Regional Director DANILO E. VERSOLA** with office address at Rawis, Legaspi City, hereinafter referred to as **DPWH**;

and

The CITY GOVERNMENT OF NAGA, with office address at J. Miranda Ave., City Hall Compound, Naga City, represented by its City Mayor JOHN G. BONGAT, as duly authorized by the Sangguniang Panlungsod through SP Res. No. _______ entitled: Resolution authorizing the Honorable City Mayor John G. Bongat to enter into a Memorandum Of Agreement (MOA) for and in behalf of the City of Naga with the Department of Public Works And Highways, Region V, represented by Regional Director Danilo E. Versola, for the lending of Amphibious Excavator (AE6) to be used for the Dredging and Sedimentation/Siltation collection of Naga River in the City of Naga.

WITNESSETH

WHEREAS, it is the basic policy of the government to ensure the expeditious delivery of service to the people, thereby accelerating economic development and strengthen peace and security in the area;

WHEREAS, the DPWH, is willing to extend support to the City Government of Naga by way of providing said dredging equipment under the rental-free scheme which when completed will help improve the socio-economic condition of the people in the area;

NOW, THEREFORE, for and consideration of the foregoing premises and of the mutual covenants and stipulation hereinafter set forth, the **DPWH** by these presents, hereby demises, conveys and lends unto the **CITY** the equipment herein specified, to wit:

This agreement shall be subject to the following conditions mutually agreed upon the parties;

1. The above describes equipment shall be used exclusively for the:



JF PROJECT LOCATION Dredging and adimentation/siltation collection From Barangay Tabuco - Barangay Sabang I. Area from the flood gate bridge, Naga City at Naga River People's Mall, Eurotel Area "Danlugan". Panganiban Bridge, Barangay Dinaga and Barangay Lerma, Barangay San Francisco to Colgante Bridge, Barangay Dayangdang and Barangay Peñafrancia. II. From Barangay Dayangdang - Barangay Peñafrancia after Colgante Bridge to Magsaysay Bridge and "Danlugan" Barangay Balatas - Barangay San Felipe Area. From "Danlugan ni Ina" Basilica site to Balatas - Sto. Niño Area.

2. Within the intent and purpose to realize the speedy completion of the above-named project, the CITY and the DPWH REGION V hereby agrees to the following:

A. The CITY shall

- Act as the executing agency and shall oversee the general operations of the dredging equipment;
- 2. Administer the use of funds provided/allocated by the City for the project;
- Employ additional/personnel at its own expense as may be necessary to provide support for efficient implementation of the dredging works;
- 4. Upon approval of this Memorandum of Agreement, shall provide the cost of the mobilization and demobilization of the equipment as the case maybe from the DPWH station to the project and vice versa including towing and hauling of its accessories;
- Provide for the motorboat to transport of personnels, fuel, oils and lubricant needed for the equipment and additional personnel to assist the DPWH in securing the equipment from any third persons.

Shall submit implementation schedule of the project for monitoring purposes.
 Attached herewith Program – Of – Work for the project, as approved by —
 Hon. John G. Bongat – City Mayor, Naga City, chargeable on the Naga River Revitalization fund.







PWH Region V shall

- 1. Assign on temporary basis the Amphibious Excavator (AE6) initially for a period of six (6) months. However, the said equipment shall be subject for recall at any time during the authorized period when interest so demand or during emergency to prevent loss of lives and properties;
- 2. Provide personnel with expertise or specialization in the dredging project;
- 3. Implement the dredging operation in accordance with the approved plans and specifications;
- 4. Appraise the higher authorities as maybe necessary regarding its accomplishments and any problems encountered concerning operations; and
- 5. Provide other technical assistance as maybe necessary in the dredging operations.
- C. The **DPWH**, Camarines Sur 2nd Engineering District shall;
 - 1. Oversee the disbursement, approval and liquidation of the Naga River Dredging Fund under the DPWH sub-allotment #SR2016-09-011013 dated September 29, 2016.
- 3. The **DPWH** shall retain custody and control of the equipment Amphibious Excavator (AE6) be fully responsible for the maintenance of the unit and shall provide needed fuel and lubricants for the effective operation of the dredging equipment during the entire period of this agreement;
- 4. That the CITY will save the DPWH and all DPWH's employees free from liability for lawsuits, civil and criminal, arising from damage done to any person or property by reason of the use, transportation, except in cases, where it proven that such damage was due to the fault of the **DPWH's** personnel.









This **AGREEMENT** shall take effect upon approval of this Memorandum of Agreement (MOA) by the Honorable Secretary, **DPWH.**

This Memorandum of Agreement may be terminated in the event of a default by the other party of any of its obligation and shall be automatically terminated upon the realization of the purposes of this **MOA**.
