**RESOLUTION GRANTING MR. ROBERT S. ARANDIA OF A & J AMUSEMENT CENTER, A PERMIT TO ESTABLISH, OPERATE AND MAINTAIN A CARNIVAL AT THE VACANT LOT NEAR THE SABANG HIGH SCHOOL AND THE LEFT PORTION OF LCC MALL NAGA CALLED DST LOT FROM JULY 15 TO SEPTEMBER 30, 2017, SUBJECT TO THE PAYMENT OF AMUSEMENT TAX TO BE DETERMINED BY THE OFFICE OF THE CITY TREASURER, AND TO CERTAIN TERMS AND CONDITIONS:-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the letter dated May 2, 2017 of Mr. Robert S. Arandia of A & J Amusement Center, applying for a permit to operate a carnival at the vacant lot near the Sabang High School and the left portion of LCC Mall Naga called DST lot, Barangay Sabang, this city;

**WHEREAS**, the Barangay Council of Sabang interposes no objection to the said application of Mr. Arandia for a permit to operate the said carnival;

**WHEREAS**, finding the same to be in order;

**NOW, THEREFORE**, on motion of Hon. Jose C. Rañola, seconded by Hon. Julian C. Lavadia Jr. and Hon. Joselito S.A. del Rosario;

**BE IT RESOLVED**, as it is hereby resolved, to grant Mr. Robert S. Arandia of A & J Amusement Carnival, a permit to establish, operate and maintain a carnival at the vacant lot near the Sabang High School and the left portion of LCC Mall Naga called DST lot from July 15 to September 30, 2017, subject to the payment of amusement tax to be determined by the Office of the City Treasurer, and to the following terms and conditions:

1. There shall be no money to be given as a prize;
2. No bingo shall be allowed to be played;
3. There shall be no request for an extension of time once the period shall expire;
4. Upon payment of all taxes;
5. To submit a certification issued by a Mechanical Engineer as to the safety of the rides, and a certification from the Office of the City Engineer as to the safety of the public.




