WHEREAS, on 25 October 2016, the City Government of Naga passed Resolution No. 2016-458 expressing its intent to join and be part of the Department of Agriculture's Programs on Rice Producers' Center (RPC) and LGU Corporate Rice Farming;

WHEREAS, one of the requirements of the aforesaid program of the national government is for the city government to identify an area in its territorial jurisdiction as its Rice Processing Center;


