RESOLUTION NO. 2017-326

RESOLUTION APPROVING THE CHARGING AGAINST THE NAGA RIVER REHABILITATION AND DEVELOPMENT FUND THE AMOUNT OF FOUR MILLION FOUR HUNDRED SEVENTEEN THOUSAND PESOS (P4,417,000.00) TO COVER THE HAULING OF MATERIALS LEFT IN CONNECTION WITH THE PREVIOUS NAGA RIVER DREDGING ACTIVITIES:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated May 19, 2017 of His Honor, the City Mayor, withdrawing his earlier request for authority dated May 12, 2017 to charge against the Naga River Rehabilitation and Development Fund and submitting the Program of Work for the Naga River Dredging Project;

WHEREAS, in the said letter dated May 12, 2017, the Honorable City Mayor requested for authority to charge P4,417 Million against the Naga river Rehabilitation and Development Fund for the following expenditures:

1. Watercrafts 2. Fuel	P 381,000.00 500,000.00
3. Rent Expenses	3,536,000.00
TOTAL	P 4,417,000.00

WHEREAS, under the approved program of Work, the amount of P4,417,000.00 is the estimated cost if the city will handle the collection and hauling of materials left after the Naga River dredging activities;

WHEREAS, finding the same to be in order and necessary to finally clear the Naga River by hauling the materials left by the project;

NOW, THEREFORE, on motion of Hon. Cecilia Veluz-De Asis, seconded by Hon. Elmer S. Baldemoro;

BE IT RESOLVED, as it is hereby resolved, to approve the charging against the Naga River Rehabilitation and Development Fund the amount of Four Million Four Hundred Seventeen Thousand Pesos (P4,417,000.00) to cover the hauling of materials left in connection with the previous Naga River Dredging Activities.
