**RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE WITH MA. CRISTINA MERCADO, ANTONIO DEJORAS, EMELIANA MERCADO AND EXEQUIEL VILLACORTA FOR THE PURCHASE OF THEIR LOT CONSISTING 76,623 SQUARE METERS LOCATED AT PACOL FOR THE CITY'S URBAN POOR HOUSING PROGRAM: -**

**WHEREAS,** received by the Sangguniang Panlungsod for appropriate action is the letter dated June 20, 2017 of His Honor, the City Mayor, requesting authority to negotiate with Ma. Cristina Mercado, Antonio Dejoras, Emeliana Mercado and Exequiel Villacorta, landowners, who offered to sell a 76,623 square-meter property located at Barangay Pacol, this city, for the city's Urban Poor Housing Program;

**WHEREAS,** after reviewing the location of the property vis-avis the existing and proposed Comprehensive Land Use Plan (CLUP), in his letter dated 17 July 2017, the City Planning & Development Coordinator manifested that the subject property is ideal for a socialized housing project for beneficiaries of the Kaantabay sa Kauswagan (KsK) Program;

Cristina Mercado, Antonio Dejoras, Emeliana Mercado and Exequiel Villacorta for the purchase of their lot consisting 76,623 square meters located at Barangay Pacol for the city's Urban Poor Housing Program.


