RESOLUTION DENYING THE LETTER DATED NOVEMBER 5, 2017 OF MR. SUHAIBANIE ARIMAO REQUESTING FOR RECONSIDERATION BY ALLOWING THEM TO SELL ANY ITEMS FOR THREE (3) MONTHS FROM OCTOBER 15, 2017 TO JANUARY 15, 2018 ON THE PROPERTY OF MR. ALAN LO TAN LOCATED BETWEEN SM-CITY NAGA AND BICOL CENTRAL STATION (BCS), AND DIRECTING THE OFFICE OF THE CITY TREASURER TO REFUND THE SPECIAL PERMIT FEE AMOUNTING TO SIX THOUSAND PESOS (P6,000.00) INCLUDING THE BUSINESS TAX-RETAILER PAID BY CERTAIN STALL HOLDERS:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated November 5, 2017 of Mr. Suhaibanie Arimao requesting for consideration of the order issued by the Sangguniang Panlungsod to the Office of the City Treasurer to immediately suspend any action including the selling of items at Tan property on the basis of the following:

1. That they were able to execute a Lease Contract with Jasaca Realty Corporation under Mr. Alan Tan from October 15, 2017 to January 15, 2018;
2. That they were issued a Special Permit as transient vendor from October 15, 2017 to January 15, 2018, and paid the amount of P6,000.00;
3. That the 20 stall holders paid the Business Tax-Retailer in the amount of P3,000.00 each.

WHEREAS, in open session, the Acting City Administrator informed the Sangguniang Panlungsod that Mr. Suhaibanie Arimao was advised to secure first a clearance from the Office of the City Engineer, and a permit from the Sangguniang Panlungsod, unfortunately, the said requirements were not secured and presented;

NOW, THEREFORE, on motion of Hon. Vidal P. Castillo, seconded by Hon. Joselito S. A. del Rosario and Hon. Salvador M. del Castillo;

BE IT RESOLVED, as it is hereby resolved, to deny the letter dated November 5, 2017 of Mr. Suhaibanie Arimao requesting for reconsideration by allowing them to sell any items for three (3) months from October 15, 2017 to January 15, 2018 on the property of Mr. Alan Lo Tan located between Sm-City Naga and Bicol Central Station (BCS), and directing the Office of the City Treasurer to refund the Special Permit Fee amounting to Six Thousand Pesos (P6,000.00) including the Business Tax-Retailer paid by certain stall holders.




