WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated December 7, 2017 of Mr. Francisco M. Mendoza, Acting HRMO, requesting for the passage of a resolution granting authority to the city mayor to enter into a Memorandum of Agreement public and private high schools of Naga City who express intent to partner with the city government in the implementation of Senior High School Work Immersion Program, subject to the absorptive capacity of city government's departments and offices;
