**RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A NEW MEMORANDUM OF AGREEMENT WITH THE NAGA CITY EMPLOYEES AND WORKERS COOPERATIVE (NACEMWCO) REGARDING THE RENTAL OF THE STALLS SITUATED AT THE NAGA CITY PEOPLE'S HALL AND, IN THE MEANTIME, EXTENDING THE EFFECTIVITY OF THE EXISTING AGREEMENT AND THE TERMS THEREOF UNTIL A NEW AGREEMENT IS PERFECTED AND SUCCESSFULLY ENTERED INTO BY THE CITY GOVERNMENT OF NAGA AND NACEMWCO:-**

**WHEREAS**, on 11 August 2017, the Naga City Employees and Workers Cooperative (NACEMWCO) adopted NACEMWCO Resolution No. 2017-08 requesting the City Mayor for the renewal of the Memorandum of Agreement between said cooperative and the City of Nga regarding to the operation, management and maintenance of the commercial stalls in the Naga City People's Hall;

**WHEREAS**, the existing MOA between NACEMWCO and the City Government of Naga in connection with the aforesaid matter already expired in February 2017;

**WHEREAS**, after careful study and hearing, the 12<sup>th</sup> Sangguniang Panlungsod of Naga found that it is in order and beneficial for the city for the City Mayor to enter into a new MOA with the NACEMWCO;

**WHEREAS**, due to expiration of the present MOA and in the absence of a new one, the terms and conditions on the rental of the stalls in the Naga City People's Hall shall be held at the status quo until the a new agreement between the City of Naga and NACEMWCO is perfected and successfully entered into by the parties;

**NOW, THEREFORE**, on motion of Hon. Salvador M. Del Castillo, seconded by Hon. Mila S.D. Raquid-Arroyo and Hon. Elmer S. Baldemoro;

**BE IT RESOLVED**, as it is hereby resolved, to authorize the City Mayor to enter into a new Memorandum of Agreement with the Naga City Employees and Workers Cooperative (NACEMWCO) regarding the rental of the stalls situated at the Naga City People's Hall and, in the meantime, extending the effectivity of the existing agreement and the terms thereof until a new agreement is perfected and successfully entered into by the City Government of Naga and NACEMWCO;
