ORPIADA IN CONNECTION WITH HIS PARTICIPATION TO THE YOUNG ACHIEVER CORPORATE SOCIAL RESPONSIBILITY ON JANUARY 26, 2018 IN NEW DELHI, INDIA, CHARGEABLE AGAINST THE DONATION ACCOUNT OF THE CITY MAYOR'S OFFICE, SUBJECT TO THE CONDITION MANDATED BY ORDINANCE NO. 2005-029:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the endorsement dated 15 January 2018 of His Honor, the City Mayor, relative to the request for financial assistance of Mr. Paul Andrew C. Orpiada relative to his participation to the Young Achiever Corporate Social Responsibility in New Delhi, India on January 26, 2018;

WHEREAS, per deliberation of the Sangguniang Panlungsod, the grant of P10,000.00 as financial assistance to Mr. Orpiada, shall be subject to the strict compliance with the requirements of Ordinance No. 2005-029, particularly the submission of a terminal report regarding the activity he attended in;

WHEREAS, failure of Mr. Orpiada to submit the needed report within 15 days from the end of the aforesaid activity and his arrival to the Philippines shall give rise to his liability to reimburse the city government of the herein amount of financial assistance he received, as well as cause him to be disqualified as grantee from any future assistance;

NOW, THEREFORE, on motion of Hon. Cecilia Veluz-De Asis, seconded by Hon. Mila S.D. Raquid-Arroyo, Hon. Joselito S.A. del Rosario and Hon. Ray-An Cydrick G. Rentoy;

BE IT RESOLVED, as it is hereby resolved, to authorize the City Treasurer and the City Accountant to disburse the amount of Ten Thousand Pesos (P10,000.00) as financial assistance to Mr. Paul Andrew C. Orpiada in connection with his participation to the Young Achiever Corporate Social Responsibility on January 26, 2018 in New Delhi, India, chargeable against the Donation Account of the City Mayor's Office, subject to the condition mandated by Ordinance NO. 2005-029.
