RESOLUTION AUTHORIZING THE CITY TREASURER AND THE CITY ACCOUNTANT TO DISBURSE THE AMOUNT OF EIGHTY THOUSAND PESOS (P80,000.00) AS FINANCIAL ASSISTANCE TO LIBOTON FIRE BRIGADE TEAM TO COVER THE PURCHASE OF CERTAIN EQUIPMENT NECESSARY IN CONNECTION WITH THEIR PARTICIPATION TO THE REGIONAL FIRE BRIGADE FIRE OLYMPICS TO BE HELD IN LEGASPI CITY ON APRIL 6, 2018, CHARGEABLE AGAINST THE BARANGAY SUPPORT FUND, SUBJECT TO THE CONDITION THAT THE SAID EQUIPMENT SHALL REMAIN AS PROPERTY OF THE NAGA CITY GOVERNMENT:-

WHEREAS, received by the Sangguniang Panlungsod for appropriate action is the letter dated March 21, 2018 of B/Kgd. Alex C.
