



**RESOLUTION AUTHORIZING HIS HONOR, THE CITY MAYOR TO NEGOTIATE FOR THE PURCHASE OF THE ENTIRE PROPERTY OF UNITED COCONUT PLANTERS BANK (UCPB) COVERED BY TCT NO. 086-2013000044 WITH A TOTAL AREA OF 5,465 SQUARE METERS LOCATED AT BARANGAY MABOLO, NAGA CITY, AS SITE OF MABOLO BARANGAY HALL, ROAD LOT AND SOCIALIZED HOUSING PURPOSES, SUBJECT TO THE RATIFICATION BY THE SANGGUNIAN NG PANLUNGSOD:-**

**WHEREAS**, received by the Sangguniang Panlungsod for appropriate action is the 1<sup>st</sup> Indorsement dated February 26, 2018 from His Honor, the City Mayor, requesting for authority to purchase the entire UCPB lot in Barangay Mabolo covered by TCT No. 086-2013000044 with a total area of 5,465 square meters to be comprised of 1) 2,920 square meters for Barangay Mabolo Hall Complex, 2) 342 square meters existing road lot, and 3) 2,203 square meters across the road for socialized housing;

**WHEREAS**, in its Resolution No. 014-2016, the Barangay Council of Mabolo requested the city government through the Sangguniang Panlungsod to allocate funds for the purchase of the subject lot for the construction of Mabolo Barangay Hall;

**WHEREAS**, finding the acquisition of the said lot to be in order and beneficial to the Barangay Government of Mabolo and its constituents;

**NOW, THEREFORE**, on motion of Hon. Salvador M. del Castillo, seconded by Hon. Gregorio R. Abonal, Hon. Vidal P. Castillo and Hon. Tomas Ramon A. Sanchez Jr.;

**BE IT RESOLVED**, as it is hereby resolved, to authorize His Honor, the City Mayor to negotiate for the purchase of the entire property of United Coconut Planters Bank (UCPB) covered by TCT No. 086-2013000044 with a total area of 5,465 square meters located at Barangay Mabolo, Naga City, as site of Mabolo Barangay Hall, road lot and socialized housing purposes, subject to the ratification by the Sangguniang Panlungsod.
