On joint and collective motion

WHEREAS, the community celebration or commemoration of certain events, occasions, or periods in our national or local history is one of the ways in ensuring that the significance of these events will remain in the consciousness and way of life of all generations, both present and future;

WHEREAS, to pave the way for meaningful celebration or commemoration of these significant events in the history of our nation, the dates corresponding to these events or occasions have been declared by law or legal issuances as public holidays;

WHEREAS, the decision of our national leaders during the time of President Gloria Macapagal Arroyo, dubbed as "holiday of economics", which literally moved the dates for the celebration or commemoration of these events whenever the true date thereof falls on dates other than Mondays or Fridays, had courted confusion especially in the mind of our young people and invited the risk of losing the true meaning of these celebrations or commemorations;

WHEREAS, fortunately, that "holiday of economics" of was debunked and corrected when then President Noyoy Aquino took office and restored the public holidays for the celebration or commemoration of the significant events in the history of our nation back to the true dates thereof;


